1. File a new application for citizenship,
OR
2. Provide proof that you **could not appear for good reason**. You must do this within sixty (60) days of the aforementioned date.

- **All requirements should be submitted with two (2) CLEAR AND LEGIBLE photocopies together with the duly accomplished Petition form.**
