LIST OF REQUIREMENTS FOR PASSPORT SERVICES

Renewal of Passport

Personal appearance is a must

Original copy of the latest Philippine Passport and photocopy of the data page/s;

Photocopy and/ or Original of evidence of legal status in Canada; (e.g. Permanent Residence Card, valid Record of landing, valid work permit, , valid visitor's visa or valid seaman's book).

Optional: If you want your passports mailed to you, please provide a pre-paid XPRESSPOST envelope from Canada Post.

If passport being renewed is the brown edition (does not bear the full middle name) proof of middle name is required such as birth certificate, baptismal, old NBI, school records or old ID's issued in the Philippines.

Applicant in decent attire; male applicant wearing decent shirt, with collar and lady applicant in decent attire (with sleeves, with or without collar but no plunging neckline).

Use of eyeglasses is acceptable provided there is no glare from the glasses and applicant's eyes are visible. Use of contact lenses for medical reasons is allowed, provided it does not change the true eye color. Use of sunglasses is not acceptable.

Fee of <u>C\$69.00</u> payable in cash, money order or certified cheque payable to Philippine Consulate General. **Personal cheque is not acceptable**.

If old Philippine passport had already been expired for 5 years or more, proof that Permanent Residence card has already been applied for or a certification from Citizenship & Immigration Canada that applicant has not acquired Canadian citizenship is required.

Authorization letter is required if the applicant cannot appear in the Consulate to claim his/her new passport and old passport must be presented for cancellation prior to the release of the new one.

A. AMENDMENT (Change of family name due to marriage)

Marriage solemnized In the Philippines;

 Original and photocopy of authenticated marriage certificate issued by National Statistics Office (NSO) in the Philippines.

2. Marriage solemnized in Canada

- a) Duly-accomplished Report of Marriage Forms (in four (4) original copies); and one photocopy
- Original and four (4) photocopies of Marriage License or Registration of Marriage (long form) issued by the Office of the Civil Registrar General;
- Certificate of Finality of Nullity of Marriage issued in the Philippines must be authenticated by the Department of Foreign Affairs, if previously married;

Four (4) passport-size photographs each of husband and wife;

- Four (4) photocopies of a valid passport, or any valid photo ID, of husband and wife.
- Passport renewal fee of C\$69.00 and Report of Marriage fee of C\$28.75 payable in cash, money order or certified cheque payable to the Philippine Consulate General.

B. REPLACEMENT OF LOST PASSPORT

- Duly accomplished application form;
- 2. Authenticated birth certificate issued by the National Statistics Office in the Philippines;
- Supporting documents (e.g. old Philippine passport, or photocopy of lost passport, baptismal certificate, school records, etc.);

Duly notarized affidavit of loss / destruction of passport;

Copy of police report from Canadian Police Records Bureau;

 Fee of <u>C\$103.50</u> for a non electronic passport and <u>C\$172.50</u> for an electronic ePassport, <u>C\$28.75</u> for affidavit of lost and <u>C\$19.68</u> for confirmation report (if lost passport was issued in the Philippines or other Foreign Service post).
 (Note: Lost passport issued at DFA Manila, Regional Consular Extension Office or other Foreign Service Post abroad is subject for verification. New passport will be processed after the confirmation is received or fifteen (15) working days from the date of filing if the

documents are complete.) C. Issuance of Passport to Children Born in Canada of Filipino Parents

- Personal appearance;
- Duly accomplished passport application form;
- Original and four (4) photocopies of Statement of Live Birth (long form) issued by the Office
 of the Civil Registrar General, Canada;
- 4. Four passport-size photographs (50 mm x 40 mm) for the Report of Birth application forms;
- Report of Birth forms (in four (4) original copies) and one photocopy to be accomplished by a parent or guardian;
- Documentary evidence of Philippine citizenship of father or mother at the time of birth of child:
- Report of Birth fee of <u>C\$28.75</u> payable in cash, money order or certified cheque payable to the Philippine Consulate General.

Note: A letter of authorization is required if the passport will be claimed by somebody else other than the applicant.
